Penick & Sons, Inc., a corporation, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY 32ND STREET, LOGAN AVENUE, WABASH BOULEVARD, NEWTON AVENUE, 29TH STREET, NATIONAL AVENUE, 31ST STREET, VALLE AVENUE, 30TH STREET AND OCEAN VIEW BOULEVARD (CONTRACT 33) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742902.
