That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ARTHUR D. LITTLE, INC., a California corporation, to conduct a survey of the environmental and economic impact of the tourism industry on the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 743633.

BE IT FURTHER RESOLVED, that the expenditure of \$100,000 from the Transient Occupancy Tax Contingency Reserve (Fund 223, Dept. 52.29) is hereby authorized solely and exclusively for the aforesaid survey.
