BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$21,941.00 by Silver Strand Contractors, a Partnership, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY 24TH STREET, COMMERCIAL STREET, FRANKLIN AVENUE, EVANS STREET, IMPERIAL AVENUE, 25TH STREET, AND "L" STREET (Contract 32), in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742966.
2. That the expenditure of \$26,000.00 is hereby authorized out of the Special Fund (Fund No. 2714) of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY 24TH STREET, COMMERCIAL STREET, FRANKLIN AVENUE, EVANS STREET, IMPERIAL AVENUE, 25TH STREET, AND "L" STREET (Contract 32) in the City of San Diego, and related costs.
