2. That the expenditure of \$41,000.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF COMMUNITY CONCOURSE IMPROVEMENT - WEST TERRACE LEVEL, in the City of San Diego, and related costs.
