

RESOLUTION NO. 208086 JUN 5 1973

RESOLUTION APPROVING RATES OF ADMISSION
TO ZOOLOGICAL GARDENS AND SPECIAL EXHIBIT
AS REQUESTED BY BOARD OF TRUSTEES OF SAN
DIEGO ZOOLOGICAL SOCIETY.

WHEREAS, the operating Agreement between the Zoological Society of San Diego, herein called "Society," and The City of San Diego, herein called "City," requires Council approval for setting of admission fees; and

WHEREAS, the Board of Trustees of Society has requested an increase in the price of admission for entrance to the Zoological Gardens at Balboa Park; and

WHEREAS, The Board of Trustees of the San Diego Zoological Society has filed with the City Clerk Document No. 743682 an affirmative action program consistent with that program adopted by City by Resolution No. 204843 on February 8, 1972; and

WHEREAS, increased costs for salaries, supplies, utilities, services, bond principal and interest will necessitate a reduction in the programmed long-range capital improvement program of the Society unless this increase is approved; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to paragraph 8 of the Operating Agreement between the City and Society, the following maximum rates of admission requested by Society for entrance to the Zoological Gardens in Balboa Park are hereby approved:

Persons 16 and over \$2.00.

Persons under 16 No charge.

In addition to the foregoing rates, the following rates are hereby approved for admission to the Children's Zoo:

Persons 16 and over \$0.25

Children 2 to 16 \$0.15

Children under 2 No charge.

This resolution shall take effect and be in force on and after the first day of July, 1973.
