BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, District Agreement Nos. 11-0114 and 11-4099 with the STATE OF CALIFORNIA, DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, for the financing and reconstruction of the 47th Street Underpass grade separation project in conjunction with the State's adjacent Interstate Route 805 freeway construction contract, within the City of San Diego, under the terms and conditions of the form of District Agreements on file in the office of the City Clerk as Document Nos. 743705 and 743704, respectively.

BE IT FURTHER RESOLVED, that the expenditure of \$180,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the design, construction and related expenses in connection with the foregoing agreements.
