BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, District Agreement No. 11-0095 with the STATE OF CALIFORNIA, DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, for the widening of MARKET STREET, from Toyne Street to 47th Street, and 47TH STREET, from Hartley Street to Market Street, in the State's proposed freeway construction project, in the City of San Diego, under the terms and conditions of the form of District Agreement on file in the office of the City Clerk as Document No. 743706.

BE IT FURTHER RESOLVED, that the expenditure of \$250,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the design, construction and related expenses in connection with the foregoing agreement.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all the necessary work for the relocation of water meters and fire hydrants in conjunction with the above referenced project, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
