BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a representative of the Police Department and a representative of the Data Processing Department be and they are hereby authorized to travel to Dallas, Texas; Jacksonville, Florida; and West Palm Beach, Florida, from June 18 to June 22, 1973, and to Seattle, Washington, from June 25 to June 27, 1973, for the purpose of conducting on-site inspections of existing computer-aided dispatch systems, and to incur all necessary expenses.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer within the 100 Fund from the Unallocated Reserve (53.30) to Allocated Reserve (53.20) the sum of \$1,636 to be used solely and exclusively for the above purpose.
