

RESOLUTION NO. 208103 JUN 7 1973

WHEREAS, The City of San Diego provides large and costly instruments for the San Diego Youth Symphony which is sponsored by the City's Park and Recreation Department and said Symphony is in need of a harp to complete its inventory of instruments; and

WHEREAS, the American Harp Society, Inc. has generously contributed to The City of San Diego the sum of \$1,693.26 to provide approximately one-half of the purchase price of a harp to be utilized by the Symphony; and

WHEREAS, said offer is contained in a letter dated November 29, 1972 and is on file in the office of the City Clerk as Document No. 743726; and

WHEREAS, the Auditor and Comptroller has deposited said generous contribution into Trust Fund 3021, Account 9660; and

WHEREAS, The City of San Diego is to provide matching funds of \$1,703.25 which are available in the Fiscal 1973 Recreation Division Budget (22.00) for its share of the purchase price of \$3,396.51 of said harp; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City of San Diego hereby accepts the generous contribution of \$1,693.26 from the American Harp Society, Inc. for the sole and exclusive purpose of providing approximately one-half of the purchase price for a harp to be utilized by the San Diego Youth Symphony.

2. That this Council does hereby commend the American Harp Society, Inc. for this act of civic generosity and does hereby publicly express on behalf of the citizens of San Diego a debt of gratitude to the American Harp Society, Inc.
