WHEREAS, the American Harp Society, Inc. has generously contributed to The City of San Diego the sum of \$1,693.26 to provide approximately one-half of the purchase price of a harp to be utilized by the Symphony; and

1. The City of San Diego hereby accepts the generous contribution of \$1,693.26 from the American Harp Society, Inc. for the sole and exclusive purpose of providing approximately one-half of the purchase price for a harp to be utilized by the San Diego Youth Symphony.

2. That this Council does hereby commend the American Harp Society, Inc. for this act of civic generosity and does hereby publicly express on behalf of the citizens of San Diego a debt of gratitude to the American Harp Society, Inc.
