

RESOLUTION NO. 208104 JUN 7 1973

WHEREAS, application for transfer of two Certificates of Public Convenience and Necessity from Liberty Cab Company to Bell, Jackson and Lyons, Inc., dba San Diego Cab Company, has been received; and

WHEREAS, the City Manager has made his recommendations pursuant to San Diego Municipal Code, Section 72.01; and

WHEREAS, Bell, Jackson and Lyons, Inc., dba San Diego Cab Company, will continue to base the operation of taxicab service within Southeast San Diego and will continue to supply minority business opportunities and employment to the Southeast San Diego area through said operation pursuant to Resolution No. 206500 passed by this City Council on September 12, 1972; and

WHEREAS, Bell, Jackson and Lyons, Inc., dba San Diego Cab Company, will base the two additional cabs allowed by the transfer herein approved within the Southeast San Diego area; and


WHEREAS, the additional taxicab service authorized by the transfer herein approved will be radio equipped; and

WHEREAS, this City Council expressly finds that the public convenience and necessity would best be served by extended service in Southeast San Diego and that this finding is in conformance with Council Policy 500-2(4);  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego  
as follows:

That pursuant to subparagraph (h) of Section 72.01 of  
the San Diego Municipal Code, the Council approves the  
transfer of two Certificates of Public Convenience and  
Necessity to operate taxicabs from Dusty Joe Wheeler dba  
Liberty Cab Company to Bell, Jackson and Lyons, Inc., dba  
San Diego Cab Company, so long as the major stockholders  
of Bell, Jackson and Lyons, Inc. continue to be Delores  
(Bell) Jackson, Henry E. Jackson, Jr. and Elnoria (Lyons)  
Jackson.
