

RESOLUTION NO. 208123 JUN 12 1973

APPROVING MAP OF DONALD N. SHARP MEMORIAL HOSPITAL SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled "DONALD N. SHARP MEMORIAL HOSPITAL Being a subdivision of a portion of Pueblo Lot 1202, according to Map by James Pascoe in 1870, known as Miscellaneous Map No. 36 and portions of Blocks 1, 2, 5, 6, 7, 13, 14, and 16 of Chesterton, according to Map No. 2040, filed in the office of the County Recorder of San Diego County, June 27, 1927. Said portion of land lying within Chesterton having been reverted to acreage by decree of the Superior Court, County of San Diego, Case No. 247304, a certified copy being recorded November 1, 1960, File/Page No. 216914 and Case No. 252210, a certified copy being recorded on April 24, 1961, File/Page No. 70536, and May 11, 1961, File/Page No. 82075, together with paths and Normandie Street, Birmingham Drive, Sherwood Drive, Cambridge Street, Homewood Drive, Oxford Street and a portion of Westmoreland Street as closed and vacated to public use, and Vista Hill Avenue and a portion of Meadow Lark Drive as dedicated to public use, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby

approved and accepted; and said Council hereby accepts on behalf of the public, the following portion of street: portion of Meadow Lark Drive, for public purposes, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and that said easement with the right of ingress and egress for the construction and maintenance of sewer facilities as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
