BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled "FERRARI-HODGE SUBDIVISION Being a subdivision of portions of Blocks 10, 11, and Lot 1 of Block 12, of Grantville and Out Lots according to Map thereof No. 776, filed in the office of the County Recorder of San Diego County, February 16, 1894; together with portions of Olympic Avenue (formerly Lincoln Avenue), Riverdale Street, Orcutt Street (formerly Logan Avenue), Mission Gorge Road, and the alleys as vacated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following portions of streets: a portion of Friars Road, a portion of Zion Avenue, and a portion of Riverdale Street, for public purposes, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of streets are accepted on behalf of the public as heretofore stated; and that those easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
