That the City Manager be, and he is hereby authorized to execute for and on behalf of said City that document entitled "Memorandum of Understanding, Joint Government Information Center, San Diego, California," a form of which is on file in the office of the City Clerk as Document No. 743763, establishing a Joint Government Information Center in the lobby of the City Administration Building for the purpose of providing citizens with information pertaining to the City, County, State and Federal government services; said Memorandum of Understanding being terminable unilaterally with six (6) months notice by any of the participating parties.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized to execute for and on behalf of the City, at the option of the City Manager, an extension of the one year term for two (2) additional periods of one (1) year each.
