

That the City Manager be and he is hereby authorized to negotiate an agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT whereby the City will provide up to \$10,300 from Fund 100 for certain improvements to the former kindergarten classroom building at Grant Elementary School to make said building suitable for the purpose of conducting a recreation program at Calvary Pioneer Neighborhood Park which is adjacent to Grant Elementary School, said building will be assigned to the City by the School District following completion of the subject improvements.
