

RESOLUTION NO. 208142 JUN 14 1973

WHEREAS, The City of San Diego proposes to improve Miramar Road, from Old Miramar Road to Interstate 15, within the City of San Diego; and

WHEREAS, the County of San Diego has indicated that funds are available in the San Diego County Thoroughfare Program (1972-73 Funds) for such improvement; and

WHEREAS, it is necessary that The City of San Diego seek encumbrances of those funds at this date; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Thoroughfare Agreement with the County of San Diego for the improvement of Miramar Road, from Interstate Highway I-15 to Carroll Road, in the City of San Diego, under the terms and conditions set forth in the form of Thoroughfare Agreement on file in the office of the City Clerk as Document No. 743770.

2. That prior to any advertisement for bids for this particular project, an Environmental Impact Report shall be final, considered and adopted.
