

RESOLUTION NO. 208144 JUN 14 1973

WHEREAS, the South Mission Beach Park parking lot has been a source of chronic police problems, particularly during the summer months when usage of the area is extremely heavy; and

WHEREAS, the installation of approximately seven (7) street light standards would provide a reasonable level of illumination and should reduce possible disturbances in the area; and

WHEREAS, the use of City Forces to do the work is deemed more economical than if let by contract and would permit the work to proceed more readily in order to complete the project and provide maximum benefit this summer; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the expenditure of \$5,000 from Capital Outlay Fund 245 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for the installation of street light standards, and related expenses, for the South Mission Beach Park parking lot.

2. That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced project pursuant to his recommendation and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
