

RESOLUTION NO. 208145 JUN 14 1973

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, between the hours of 8:00 a.m. and 2:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on the following streets in said City:

ALCOTT STREET, both sides, between Rosecrans and Locust Streets;
BROWNING STREET, both sides, between Rosecrans and Evergreen Streets;
CURTIS STREET, both sides, between Rosecrans and Willow Streets;
DUMAS STREET, both sides, between Rosecrans and Clove Streets;
ELLIOTT STREET, both sides, between Rosecrans and Evergreen Streets;
EVERGREEN STREET, both sides, between Browning and Goldsmith Streets;
FREEMAN STREET, both sides, between Rosecrans and Evergreen Streets;
GOLDSMITH STREET, both sides, between Rosecrans and Evergreen Streets;
HOMER STREET, both sides, between Rosecrans and Locust Streets;
LOCUST STREET, both sides, between Homer and Zola Streets;
LOCUST STREET, both sides, between Russell and Macaulay Streets;
QUIMBY STREET, both sides, between Rosecrans Street and dead end;
RUSSELL STREET, both sides, between Rosecrans and Locust Streets;
STERNE STREET, both sides, between Rosecrans Street and dead end;
TENNYSON STREET, both sides, between Rosecrans Street and dead end;
WILLOW STREET, both sides, between Curtis and Elliott Streets;

YONGE STREET, both sides, between Rosecrans Street and dead end; and
ZOLA STREET, both sides, between Rosecrans and Locust Streets.

BE IT FURTHER RESOLVED, that the installation of the necessary
signs and markings be and the same are hereby authorized to be
made on said streets, and that the regulations hereinabove imposed
shall become effective upon the installation of such signs.
