BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Sunlight Electric Supply Co., 2. Westinghouse Electric Supply Co. and 3. General Electric Supply Co. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of ELECTRICAL MAINTENANCE AND REPAIR MATERIALS as follows:

1. Sunlight Electric Supply Co. for Sections 1, 2, and 4; terms, 2% 10 days, plus sales tax, subject to price escalation not to exceed 10% of bid price.
2. Westinghouse Electric Supply Co. for Section 3; terms, 2% 10 days, plus sales tax, subject to price escalation not to exceed 20% of bid price.
3. General Electric Supply Co. for Section 5; terms, 2% 30 days, plus sales tax, prices firm.
