

RESOLUTION NO. 208179 JUN 19 1973

WHEREAS, the State Planning and Zoning Law requires that the City Council adopt a conservation element prior to June 30, 1973; and

WHEREAS, the Planning Commission held public hearings on May 16 and May 23, 1973, for the purpose of considering an amendment to the General Plan text by the addition of a conservation element; and

WHEREAS, the Planning Commission, by Resolution No. 189, adopted May 23, 1973, approved said conservation element as an amendment to the General Plan text and recommended its adoption to the City Council; and

WHEREAS, this amendment will serve as a guide for the conservation, development and utilization of such basic natural resources as landforms; the ocean shoreline; water bodies; vegetation and wildlife; minerals; agricultural lands; and air;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

This Council hereby adopts that Report entitled, "Conservation Element," on file in the office of the City Clerk as Document No. 743796, as an amendment to the General Plan text.
