WHEREAS, the improvement agreements for these subdivisions require the Subdivider, PRINCESS PARK ESTATES, INC., to install 2" A.C. in the median areas of Del Sol Boulevard and Picador Boulevard; and

WHEREAS, it is not feasible to have the required median paving installed at this time as it would require its removal when the City constructs the permanent paving; and

WHEREAS, the Subdivider has placed on deposit with the City a check in the amount of \$14,107.72 in lieu of installation of the median paving; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. The City Manager is authorized to accept the work on behalf of THE CITY OF SAN DIEGO in all of the subdivisions named above and to execute Notices of Completion and have the same recorded.

2. This Council hereby authorizes the acceptance of \$14,107.72 from PRINCESS PARK ESTATES, INC., Subdivider of the above-named subdivisions, in lieu of 2" median paving of Del Sol Boulevard and Picador Boulevard.
