

RESOLUTION NO. 208191 JUN 21 1973

APPROVING MAP OF G-W INDUSTRIAL PARK UNIT NO. 2 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "G-W INDUSTRIAL PARK UNIT NO. 2 Being a subdivision of a portion of Section 11, Township 15 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey, lying northerly of the northerly line of county road survey No. 466 known as Carroll Road.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following streets and portion of street: Camino Santa Fe, Flatcar Street, Caboose Avenue, and a portion of Carroll Road, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those items listed in paragraphs 1 and 2 of the certificate signed by the Owners for: abutters' rights of vehicular access, and sewer

and drainage facilities; as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of street are accepted on behalf of the public as heretofore stated; and those items listed in paragraphs 1 and 2 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
