That the City Manager be, and he is hereby authorized and empowered to execute for and on behalf of said City, a Lease Agreement with EMMETT and IDA MAE DYKES, individuals, whereby the City leases the Southeast Involvement Project facilities for a term of eight (8) months, from June 1, 1973 to January 31, 1974, with the option of the City Manager to extend said term for three (3) additional periods of one (1) year each, at a monthly rental of \$200 plus utilities, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 743839.
