

That the City Auditor and Comptroller is hereby authorized to transfer \$374.41 to supplement Resolution No. 203298, \$422.89 to supplement Resolution No. 200067, \$357.28 to supplement Resolution No. 204757, and \$600.60 to supplement Resolution No. 204048, from Capital Outlay Fund 245 of The City of San Diego, and that the expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds to clear credit balances and allow the resolutions to be closed in connection with the improvements in the Mesa Verde Park, Memorial Park and Recreation Center and Luckie Waller Park projects.
