

RESOLUTION No. 208235


Adopted on JUN 26 1973

That the acceptance by the City Manager of that deed of RICHARD JOHN LAREAU AND ASSOCIATES, INC., a California corporation, executed in favor of The City of San Diego, bearing date of May 1, 1973, conveying to said City an easement and right of way for street purposes over, under, upon, along and across a portion of Lot 2, Block 16 of La Playa, also shown as Block 131 of La Playa on Poole's Map of the Pueblo Lands, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named McCALL STREET.
