

RESOLUTION NO. 208236 JUN 26 1973

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Montongo Street, over and across a portion of Lot 2971, Mira Mesa Verde Unit No. 26, according to Map thereof No. 6993 filed in the office of the County Recorder on July 21, 1971; and

WHEREAS, the owner of the property has requested that the City revert these abutter's rights of access in the property to allow better utilization of the land; and

WHEREAS, said abutter's right of access are no longer needed by the City and should be reverted in the property; and

WHEREAS, it has been determined that the Community Development, Public Works and Planning Departments have no objection to the reversion of said abutter's rights; and

WHEREAS, a fee of \$120.00 has been collected to cover the processing of this request; and

WHEREAS, the City Manager recommends that said access rights be reverted in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and City Clerk of said City be and they are hereby authorized and empowered to execute for and on behalf of The City of San Diego a quitclaim deed, the form

of which is on file in the office of the City Clerk as Document No. 743875, to the OWNERS IN FEE SIMPLE OF RECORD of Lot 2971, Mira Mesa Verde Unit No. 26, effecting the revestment of those abutter's rights of access to Montongo Street of said Lot 2971, Mira Mesa Verde Unit No. 26, heretofore relinquished to the City and more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed to the Property Director of The City of San Diego for further handling.
