

RESOLUTION NO. 208214 JUN 26 1973

A RESOLUTION REGARDING THE SUBMISSION OF AN APPLICATION AND EXECUTION OF AN AGREEMENT WITH THE OFFICE OF ECONOMIC OPPORTUNITY FOR FUNDING OF THE BRIDGES TO BUSINESS FOR MINORITY STUDENTS.

WHEREAS, the Mayor of The City of San Diego declared in his 1972 State of The City Message that he would seek to provide work study opportunities for minority students who have demonstrated a high potential for success in business studies; and

WHEREAS, to achieve this objective, the Mayor has fashioned a program of Bridges to Business for Minority Students designed to attract minority students to the study of Business Administration; and

WHEREAS, the objective of this program is the enrollment of two hundred (200) minority students within the next five (5) years in the School of Business Administration at San Diego State University; and

WHEREAS, on September 28, 1972, the Mayor met with sixty-three (63) leaders of this area's business community to seek assistance and support for this program; and

WHEREAS, the Mayor received unanimous support and commitments from these business leaders to achieve the objectives of this worthy program; and

WHEREAS, the Dean of the School of Business Administration at San Diego State University has provided the necessary

technical assistance in getting this program underway and will assume the role of Program Administrator upon the funding of this program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager of The City of San Diego be, and he is hereby authorized to submit an application to the Office of Economic Opportunity for funding of the demonstration program, Bridges to Business for Minority Students, for and on behalf of said City, said form of grant application on file in the office of the City Clerk as Document No. 743888.

2. That upon approval of the grant application by the Office of Economic Opportunity, the City Manager be, and he is hereby authorized and empowered to execute for and on behalf of said City the grant agreement.
