BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager or his designated representative be, and he is hereby authorized to enter into, for and on behalf of said City, an agreement with the California Counsel on Criminal Justice accepting a grant for Law Enforcement Officers Planning and Training for San Diego County under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 743852.

BE IT FURTHER RESOLVED, that the City of San Diego agrees to provide those matching funds for the project delineated in said agreement.

BE IT FURTHER RESOLVED, that none of the grant funds for this project be used to supplant on-going law enforcement expenditures.
