BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$288,578.50 by Long, Marker & Howley Construction Co., a corporation, for CONSTRUCTION OF SEWER AND WATER MAIN REPLACEMENTS GROUP 189 (MODEL CITIES AREA) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 743378.
2. That the expenditure of \$415,000.00 is hereby authorized out of Water Revenue Fund (Fund 502) of the City of San Diego, and that the expenditure of \$39,000.00 is hereby authorized out of Sewer Revenue Fund (Fund 506) of the City of San Diego, solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SEWER AND WATER MAIN REPLACEMENTS GROUP 189 (MODEL CITIES AREA) in the City of San Diego, and related costs.
