BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the sum of \$50,000 from the San Diego Chargers, as consideration for the future use of the Multi-Sports Field adjacent to the San Diego Stadium, is hereby accepted in accordance with that certain agreement on file in the office of the City Clerk as Document No. 713932.

That the bid of \$63,786 by Valley Crest Landscape, Inc., a corporation, for improvements of Mission Valley Multi-Sports Field adjacent to the San Diego Stadium in the City of San Diego, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No. 743588.

That the expenditure of \$79,000 is hereby authorized from Capital Outlay Fund 245 solely and exclusively for the purpose of providing funds for improvements of Mission Valley Multi-Sports Field adjacent to the San Diego Stadium in the City of San Diego, and related costs.
