COOK & ASSOCIATES, LTD., a California corporation, for engineering services in connection with design and construction of MIRA MESA BOULEVARD, from Interstate 805 to Montongo Street, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 743933.

BE IT FURTHER RESOLVED, that the expenditure of \$100,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for design and related expenses.
