

RESOLUTION No. 208288

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Western Metal Supply Co., 2. Reliance Steel & Aluminum Co., 3. San Diego Pipe & Supply Co., Inc. 4. Hansson Motor Supply Inc., are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SMALL TOOLS as may be required for the period of one year beginning July 1, 1973 through June 30, 1974, per prices on file in the Purchasing Department, as follows:

1. Western Metal Supply Co. for Sections I, III, and VII; terms, 2% 30 days plus sales tax, subject to price escalation not to exceed 8% of bid price.
2. Reliance Steel & Aluminum Co. for Section II; terms, 2% 10 days plus sales tax; with option to renew for an additional year, subject to price escalation not to exceed 5% of bid price.
3. San Diego Pipe & Supply Co., Inc. for Sections IV, V, VI; terms, 2% 10 days plus sales tax; with option to renew for an additional year, subject to price escalation not to exceed 10% of bid price.
4. Hansson Motor Supply Inc. for Section VIII; terms, 2% 10 days plus sales tax, with option to renew for an additional year, subject to price escalation not to exceed 5% of bid price.
