That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with DELAWIE, MACY & HENDERSON, AIA, for architectural services required for the remodeling and rehabilitation of the La Jolla Recreation Center, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 743970.

BE IT FURTHER RESOLVED, that the expenditure of \$32,000 is hereby authorized out of Park and Recreation Bond Fund 725 of The City of San Diego, solely and exclusively for the purpose of providing funds for the design, construction and related expenses.
