

RESOLUTION No. 205313

Adopted on JUL 5 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$249,787.80 by Wilcox Electric Inc. dba Arrow Electric, a corporation, for CONSTRUCTION OF TRAFFIC SIGNALS AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF CATALINA BOULEVARD AND TALBOT STREET; HOWARD AVENUE AND TEXAS STREET; PARK BOULEVARD AND PRESIDENT'S WAY; 35TH STREET AND ADAMS AVENUE, BISBY LAKE AVENUE AND NAVAJO ROAD, AND COWLES MOUNTAIN BOULEVARD AND NAVAJO ROAD; MORLEY FIELD DRIVE, PARK BOULEVARD AND ZOO DRIVE; PARK BOULEVARD AND UNIVERSITY AVENUE, Schedule I and Schedule II, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 743379.
2. That the expenditure of \$298,800.00 is hereby authorized out of Gas Tax Fund (Fund 220) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNALS AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF CATALINA BOULEVARD AND TALBOT STREET; HOWARD AVENUE AND TEXAS STREET; PARK BOULEVARD AND PRESIDENT'S WAY; 35TH STREET AND ADAMS AVENUE, BISBY LAKE AVENUE AND NAVAJO ROAD, AND COWLES MOUNTAIN BOULEVARD AND NAVAJO ROAD; MORLEY FIELD DRIVE, PARK BOULEVARD AND ZOO DRIVE; PARK BOULEVARD AND UNIVERSITY AVENUE, Schedule I and Schedule II, in the City of San Diego, and related costs.
