Co., for CONSTRUCTION OF CLAIREMONT MESA BOULEVARD AND VIA CAPRI WATER PIPELINES in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 741513.
2. That the expenditure of \$63,000.00 is hereby authorized out of Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF CLAIREMONT MESA BOULEVARD AND VIA CAPRI WATER PIPELINES in the City of San Diego, and related costs.
