BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. V.R. Dennis Construction Co. 2. Sim J. Harris Company are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of TYPE B ASPHALT CONCRETE, as may be required for the period of one year beginning July 1, 1973 through June 30, 1974, as follows:

1. V.R. Dennis Construction Co. for Section I; terms, net 30 days plus sales tax.
2. Sim J. Harris Company for Section II; terms, net 30 days, with an option to renew contract for an additional year beginning July 1, 1974 to June 30, 1975. Prices are firm first year, subject to escalation not to exceed 10% of bid price second year.
