

RESOLUTION NO. 208366 JUL 10 1973

WHEREAS, The City of San Diego is the owner of a portion of the Oaks Tract in Rancho San Bernardo, according to Map thereof No. 1415, on file in the office of the San Diego County Recorder; and

WHEREAS, the San Diego Gas & Electric Company, a corporation, has requested the conveyance of an easement for underground electrical facilities in, under and upon said property; and

WHEREAS, the purposes for which said easement is required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act because it is the disposition of existing facilities, pursuant to Section III, A. 2a of the City Guidelines for Implementation of the California Environmental Quality Act; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That, in consideration of the benefits to accrue to
the people of said City, the Mayor and City Clerk of The
City of San Diego be and they are hereby authorized and
empowered to execute for and on behalf of said City a deed
conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corpo-
ration, an easement for underground electrical facilities
in, under and upon a portion of the Oaks Tract in Rancho
San Bernardo, as more particularly described in the form
of deed of easement on file in the office of the City Clerk
as Document No. 744045.

BE IT FURTHER RESOLVED, that the City Clerk is hereby
authorized and directed to deliver said deed to the Property
Director of The City of San Diego for further handling.
