RIEDLER, as tenants in common, executed in favor of The City of San Diego, bearing date of May 20, 1973, conveying to said City portions of Lots 7 through 12, inclusive, and Lot 24 in Block 52 of Middletown Addition, as more particularly described in said deed, for park purposes, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$10,187 is hereby authorized from San Diego Park District No. 3 Fund 3711 solely and exclusively to provide funds for the acquisition of the above described land for park purposes, as stated above.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby directed to deliver said deed to the Property Director of The City of San Diego for recording and further disposition.
