
Adopted on JUL 10 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SECURITY TITLE INSURANCE COMPANY, as Trustee of its Trust No. P. T. 1410, executed in favor of The City of San Diego, bearing date of June 6, 1973, conveying to said City all that real property being portions of Pueblo Lots 1174 and 1175, as more particularly described in said deed, for park purposes, be and the same is hereby approved.

That the expenditure of \$44,700 from Park Bond Fund 725 and \$82,200 from Capital Outlay Fund 245, for a total expenditure of \$126,900, be and the same is hereby authorized solely and exclusively for the purpose of providing funds to purchase the above referenced property for park purposes.
