

RESOLUTION NO. 208379 JUL 10 1973

APPROVING MAP OF BALBOA PARK TOWERS SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by JOSEPH C. BORWN, Registered Civil Engineer, and entitled "BALBOA PARK TOWERS Being a subdivision of Lots 1 through 10 of Block 8 and Lots 39 through 48 of Block 3, together with a portion of Seventh Avenue as dedicated to the public and a portion of Seventh Avenue as closed to public use of Crittenden Addition according to the Map thereof No. 303 filed in the office of the County Recorder of San Diego County, October 5, 1886, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following portions of street: portions of Seventh Avenue, for public purposes, and said portions of street are hereby declared to be portions of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage, sewer and water facilities,

together with the easement for open space, all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of street are accepted on behalf of the public as heretofore stated; and that those easements with the right of ingress and egress for the construction and maintenance of drainage, sewer and water facilities, together with the easement for open space, as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
