That the offer of Bayly Martin & Fay, Inc. is hereby accepted, and the City Manager is hereby authorized to execute a contract for EXCESS PUBLIC LIABILITY INSURANCE in the amount of \$9,500,000 for a period of 3 years beginning August 1, 1973, for a cost of \$41,180 per year, and \$10 million GENERAL AIRPORT LIABILITY INSURANCE for a period of 2 years beginning August 1, 1973, for a cost of \$15,500 per year.
