

RESOLUTION NO. 208425 JUL 17 1973

APPROVING MAP OF PENASQUITOS BLUFFS UNIT NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, Licensed Land Surveyor, and entitled "PENASQUITOS BLUFFS UNIT NO. 1 Being a subdivision of a portion of Section 13 in Township 14 South, Range 3 West, San Bernardino Meridian, according to official plat thereof, and a portion of Rancho De Los Penasquitos, according to Map accompanying the Patent of said Rancho recorded in the office of County Recorder of San Diego County in Book 2, Page 385 of Patents, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following streets: Rifle Way, Roundup Avenue, Sidewinder Way, Sundance Avenue, Thunderhead Street, Trail Dust Avenue, and Twin Trails Drive, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to  
the Clerk of the Board of Supervisors of the County of San Diego,  
California.
