deed, the form of which is on file in the office of the City Clerk as Document No. 744126 , conveying to BAYLOR CONSTRUCTION COMPANY, a corporation, portion of Lots 1 in Block 4, and Lot 9, in Block 3 of Rosedale, as more particularly described in said form of grant deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
