BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$4,200 from Gas Tax Fund 220 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for construction of an eight-foot bicycle lane within the Federal Boulevard right of way from State Route 94 to 60th Street.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above-referenced project pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
