That the expenditure of \$7,000.00 is hereby authorized out of the Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds to INSULATE ROOF OF BUILDING NO. 31, 20TH AND "B" STREETS, Schedule I, in the City of San Diego, and related costs.
