That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of The City of San Diego a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 744206, quitclaiming to THE UNITED STATES OF AMERICA portions of Lots 45, 47, 50 and 51 of Rosedale, according to Map thereof No. 825, filed in the office of the County Recorder of San Diego County on January 21, 1897, and as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed, together with a certified copy of this resolution, to the Mayor for execution and transmittal to the Property Director for further handling.
