public street purposes.

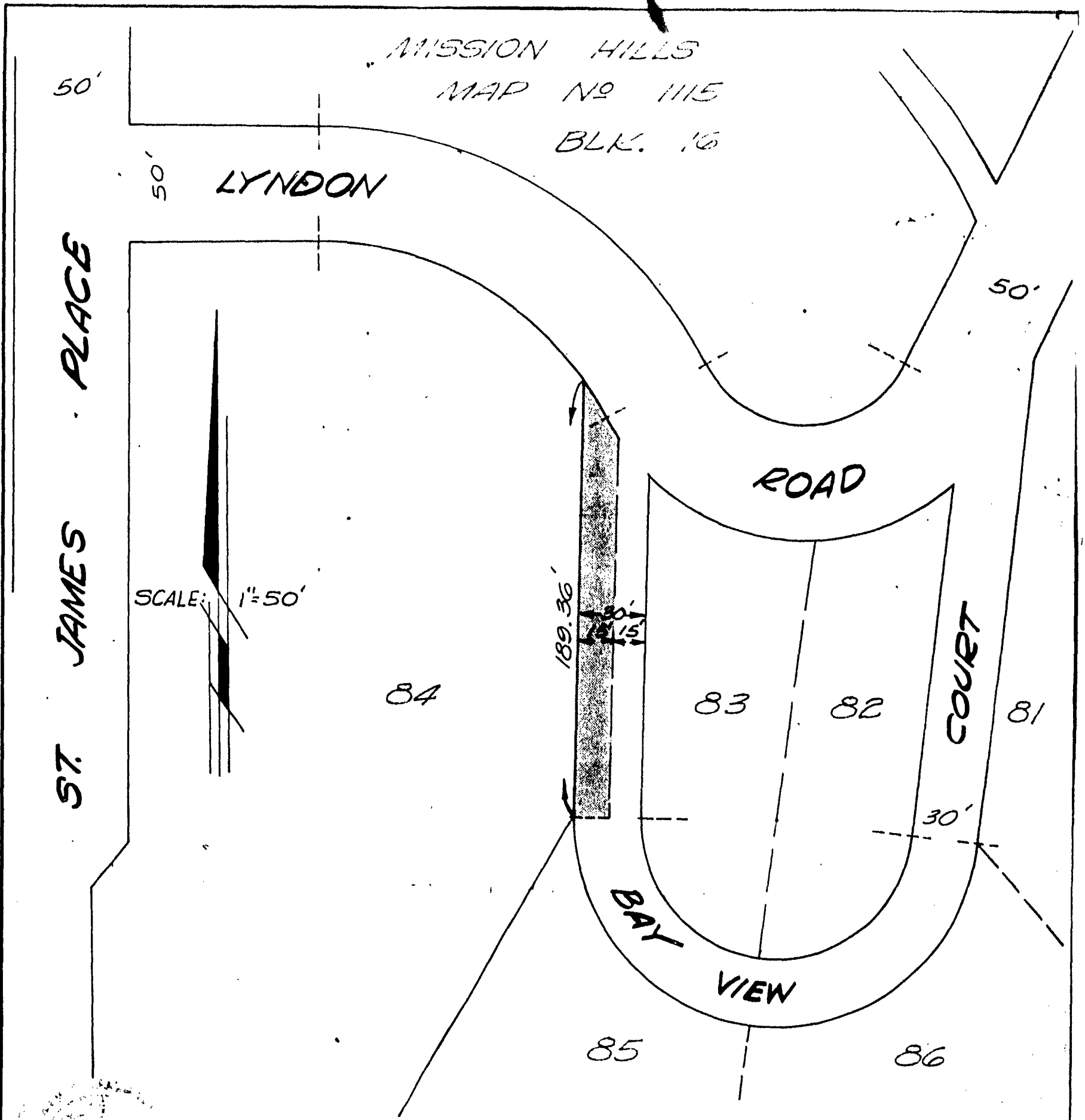
BE IT FURTHER RESOLVED that the westerly half of that
