

**RESOLUTION No.** 208467

Adopted on JUL 26 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Crosthwaite Athletic Supply 2. Berry's Sporting Goods 3. Bill Smith Sporting Goods and 4. Stanley Andrews Sporting Goods are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of 60 ITEMS OF MISCELLANEOUS ATHLETIC SUPPLIES as may be required for a period of one year beginning July 21, 1973 through July 20, 1974, per prices on file in the Purchasing Department as follows:

1. Crosthwaite Athletic Supply for Items 1, 29, 30 and 31; terms net 30 days, plus sales tax; subject to escalation not to exceed 5% of bid prices, and;

2. Berry's Sporting Goods for Items 5, 6, 42, 44, 55 and 57 through 61; terms net 30 days, plus sales tax; subject to escalation not to exceed 5% of bid prices, and;

3. Bill Smith Sporting Goods for Items 2, 3, 25, 26, 32, 33, 38 through 40, 45, 46, 50, 52, 53, and 56; terms 2% 30 days, plus sales tax; prices are firm, and;

4. Stanley Andrews Sporting Goods for Items 4, 7 through 24, 27, 28, 35 through 37, 41, 43, 47 through 49, 51 and 54; terms 2% 30 days, plus sales tax; prices subject to escalation not to exceed 5% of bid prices.
