That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City an agreement with BENTON ENGINEERING, INC., a California corporation, for soils engineering services in connection with the construction of a new North Harbor Drive Bridge and approach roads in the City of San Diego across the Navy Estuary in San Diego Bay, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 744275.

BE IT FURTHER RESOLVED, that the expenditure of \$8,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above project.
