

RESOLUTION NO. 208478 JUL 26 1973

WHEREAS, pursuant to Resolution No. 207780, The City of San Diego and V. R. Dennis Company entered into a contract for a citywide street resurfacing project, a copy of which is on file in the office of the City Clerk as Document No. 743537; and

WHEREAS, said contract permits the addition or deletion of certain projects; and

WHEREAS, it is now deemed necessary to resurface POMERADO ROAD, from Route 15 to the East City Limits (Sycamore Test Site Road); NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the expenditure of \$40,000 is hereby authorized out of Gas Tax Fund 219 of The City of San Diego, solely and exclusively for the purpose of providing funds for the resurfacing of Pomerado Road, from Route 15 to the East City Limits (Sycamore Test Site Road).

2. That this resolution is hereby incorporated by reference into the above-referenced contract with V. R. Dennis Company.
